Shall the Board of Education of the Twin Rivers R-X School District, Missouri, borrow money in the amount of Eight Million Dollars (\$8,000,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of new classrooms on the High School campus to serve as the new Junior High and an additional parking lot; to replace and/or repair roofs; to install new playground privacy fences at Qulin and Fisk Elementary Schools; to repair the drainage system; to refinish and redesign the gymnasium floor at Fisk Elementary School; to replace gymnasium bleachers; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof resulting in an estimated increase to the debt service property tax levy of \$0.8000 per one hundred dollars of assessed valuation?
